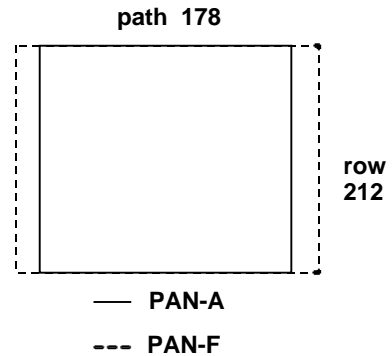
Path/row and sensor required.
